## Spotlight on Provision 10: A Global Vision for Nursing Ethics

In 2025, the American Nurses Association introduced Provision 10 to the Code of Ethics for Nurses, affirming the profession's ethical responsibility to engage in the global health community. Provision 10 states: "Nursing, through organizations and associations, participates in the global nursing and health community to promote human and environmental health, well-being, and flourishing."

This addition reflects the growing recognition that health is a global concern. From climate change and pandemics to migration and health inequities, nurses are increasingly called to lead across borders. Provision 10 acknowledges the interconnected-

ness of human and environmental health and positions nurses as ethical stewards of planetary well-being.

The inclusion of Provision 10 marks a shift from a sole national focus to a global ethical framework. It also reinforces the importance of cultural humility, solidarity, and reciprocity in global health work.
