- Legislative Awareness Committee: Developing "Facts-at-a-Glance" flyers, having completed one for S1983/A944 Eliminates Certain Restrictions for Advanced Practice Nurses and S2700/ A3683 the Patient Protection and Safe Staffing Act.
- Membership Assembly Representatives: Actively participating in ANA meetings to discuss proposed bylaws changes, and NJSNA meetings to review these bylaws, dialogue forum documents, and the candidate slate in preparation for Membership Assembly.
