Political Updates:

Although co-sponsors continue to be added to the following bills, there has been no movement on our bills. The Legislature went on summer break in June. The Assembly is up for election in November and spent the summer in their district offices fundraising. There is an expectation that meetings and voting on bills will be sporadic until after the November elections.
